ADMISSION NOTICE TO CLASS XI SCIENCE & COMMERCE (SESSION: 2026-27)

Dear Parents

Greetings of the day!

It is to inform you that with reference to our earlier notice having Ref. No. DAV PS/BLS/ 900/ 2025 dated 27.11.2025 and as per the marks of Pre-Board Examination-1, the Academic Committee has proposed to start the admission process early so that the students can use the transition gap from completion of the examination to the declaration of the result. They can attend class- XI before the declaration of the result.

Admission Forms for Class-XI for the session 2026-27 for our selected students will be available from 22.12.2025 to 08.01.2026 in school office on all working days. Students who will secure **65% in Mathematics & Science (together) or 75% in aggregate in the 1st Pre-Board Examination** for the session 2025-26 can apply for XI Science and students securing 70% in aggregate can apply for XI Commerce. The registration fee of Rs.1000/- (Rupees One Thousand only) may be paid through Debit Card / Credit Card.

The Admission Committee will accommodate the students of class-X of the school in class-XI for the session 2026-27 as per the criteria based on the performance of the students in Pre-Board Examination-1 and subsequent examinations to be conducted by the School/ Board.

The **provisional admission will be from 23.12.2025 to 08.01.2026** from 9:00am to 2.00pm on all working days. **The provisional selection list of such students will be available in the School Notice Board on 20.12.2025 at 3:00 PM.**

The Committee has been pleased to inform the offer of exemption of admission fees to the students of same school. Parents interested in admission for their wards in class-XI Science remit an amount of Rs.8440/- (only towards annual activity fee Rs.1000/- and one month school fee Rs.7440/-) & in class-XI Commerce remit an amount of Rs.7890/- (only towards annual activity fee Rs.1000/- and one month school fee Rs.6890/-).

If any student/ parent does not submit the admission form, it will be assumed that he/she is not interested in continuing in the school and his/her claim for a seat in the school will be ceased.


Further the SMC in its 14th meeting vide pt. no. 12 (iii) dated 25 February 2023, has been pleased to offer an exemption of school fees in class XI & XII to the 3 % top scorers of

the total student strength of class X. If any sorts of registered students come under the above category, their school fees shall be refunded after publication of the CBSE final result.

NB:

- The student must pass in Std-X Board Exams (CBSE-2026)
- After passing Std-X Board Exams (CBSE-2026), the student will have to submit self-attested copies of Board Mark Sheet, Board Certificates and other documents as applicable (refer to admission form).
- **Candidates may choose one of the following combinations for XI Science.**
Combination 1: English, Physics, Chemistry, Mathematics, Computer Science and Physical Education/Painting
Combination 2: English, Physics, Chemistry, Biology, Computer Science and Physical Education/Painting
Combination 3: English, Physics, Chemistry, Mathematics, Biology and Physical Education/Painting.
- **Combination for Commerce:** English, Business Studies, Accountancy, Economics, Mathematics/ Computer Science and Physical Education/Painting.
